This three-hour live, interactive training is approved by the **Department of Human Services, Education and State** and meets all requirements for training on recognizing and reporting

child abuse (to include **Act 126** for school employees).

This training is also approved for continuing education credits under **Act 31** (Department of State for health-related licenses) and **Act 48** (Department of Education for teachers) at no cost.

PFSA will submit your training verification to the Department of State or Education as appropriate on your behalf (details provided during training).
